NOTICE OF PUBLIC HEARING ON
AMBULANCE SERVICE AGREEMENT FOR THE YEAR 2026**

NOTICE IS HEREBY GIVEN that the Town Board of the Town of Maine will conduct a public hearing on November 18, 2025 at 7:00 p.m. at Maine Town Hall, 12 Lewis Street, Maine, NY with respect to a proposed agreement between the Town and the Maine Emergency Squad, Inc. ("Squad") pursuant to which the Squad agrees to furnish ambulance service within the Town of Maine, for the period beginning on January 1, 2026 and ending December 31, 2026. The payments to be made by the Town to the Squad under the Agreement shall be: (a) the approximate sum of \$10,000.00 which the Town shall pay to the Squad from the proceeds of the year 2026 Host Community Agreement contribution to be made by the County of Broome to Town, (b) a sum not to exceed \$240,709.00 which represents the amount to be raised by real estate taxes for ambulance service for the year 2026, and (c) a sum of estimated proceeds from Squad billing.

A copy of the proposed contract is on file and may be examined at the office of the undersigned Town Clerk. Any person is entitled to be heard upon said proposed contract at such public hearing. NOTICE OF PUBLIC HEARING ON
FIRE PROTECTION CONTRACTS FOR THE YEAR 2026**

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Town Board of the Town of Maine on November 18, 2025 at 7:00 p.m. at Maine Town Hall, 12 Lewis Street, Maine, NY for the purpose of considering fire protection contracts for Fire Protection Districts 2, 3, 4, 5, 6 and 7.

Each Fire Company shall, at all times during the period of said contract, be subject to call for attendance upon any fire occurring in such respective fire protection districts, and shall respond and attend upon all fire calls in said respective fire protection districts. For such services, payments shall be made by the Town pursuant to said contracts as follows:

Fire Protection District No. 2: \$77,726.00 to Union Center Fire Company, Inc.
Fire Protection District No. 3: \$66,359.00 to Union Center Fire Company, Inc.
Fire Protection District No. 4: \$10,244.00 to Glen Aubrey Fire Company, Inc.
Fire Protection District No. 5: \$12,385.00 to Maine Fire District No. 1 of the Town of Maine.
Fire Protection District No. 6: \$32,060.00 to Maine Fire District No. 1 of the Town of Maine.
Fire Protection District No. 7: \$183,304.00 to East Maine Fire Company, Inc., plus an additional sum of \$10,000 from the proceeds of a Host Community Agreement for fire protection at the Broome County Landfill.

Each contract shall continue for a period of one year, from January 1, 2026 until December 31, 2026. Copies of the proposed contracts may be examined at the office of the Town Clerk. Any person is entitled to be heard upon said proposed contracts at such public hearing.
